- 1. ALL AUCTION BUYERS INTENDING TO BID MUST HAVE A REGISTERED BUYERS NUMBER, AVAILABLE AT THE OFFICE. NO BID WILL BE ACCEPTED WITHOUT A NUMBER.**
- 2. THE AUCTIONEER HAS THE RIGHT TO REFUSE ANY BID & MAY WITHDRAW ANY LOT FROM THE AUCTION WITHOUT NOTICE**
- 3. SHOULD ANY DISPUTE ARISE IN THE BIDDING, THE RELAVENT LOT WILL BE REOFFERED FOR SALE.**
- 4. ON THE FALL OF THE HAMMER THE BUYER IS RESPONSIBLE FOR LOSS OR DAMAGE TO ANY ITEM PURCHASED.**
- 5. ALL AUCTION LOTS ARE MADE AVAILABLE FOR INSDPECTION. NO REFUNDS WILL BE MADE, NOR WILL ANY BUYER BE PERMITTED TPO REJECT ANY LOT ON THE GROUNDS THAT IT IS NOT CORRECTLY DESCRIBED. THE SAID LOTS ARE TO BE TAKEN WITH ALL FAULTS, IF ANY.**
- 6. ALL ELECTRICAL GOODS ARE SOLD AS SCRAP ONLY AND SHOULD BE SAFETY TESTED BY A LICENCED ELECTRICIAN PRIOR TO USE**
- 7. ALL ACCOUNTS ARE TO BE SETTLED WITHIN 24 HOURS OF THE COMPLETION OF THE SALE.**
- 8. REMOVAL OF ITEMS PURCHASED WILL ONLY BE ALLOWED WITH PAID INVOICE WHICH WILL BE CHECKED BY OUR STAFF.**
- 9. ALL ITEMS PURCHASED MUST BE REMOVED FROM THE WAREHOUSE FLOOR WITHIN 24 HOURS OF THE AUCTION, UNLESS PRIOR STORAGE ARRANGEMENTS HAVE BEEN MADE. ITEMS NOT REMOVED WITHIN 24 HOURS WILL INCURR DAILY STORAGE FEES.**
- 10. DELIVERIES CAN BE ARRANGED, PLEASE ENQUIRE AT THE OFFICE.**
- 11. ALL CREDIT CARD TRANSACTIONS FOR AUCTION PURCHASES INCUR A 2% LEVY ON THE TOTAL AMOUNT.**
